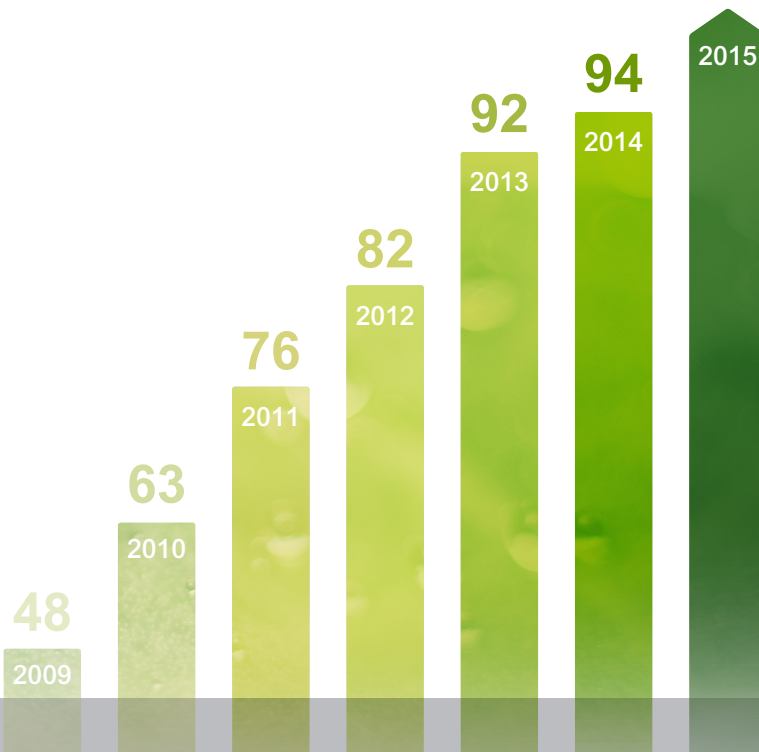

The Carbon Disclosure Project (CDP) aims to protect natural resources and help organizations measure, disclose and manage environmental risk. Broadcom joins more than 80 percent of Global 500 companies that measure greenhouse gas emissions (GHG) and disclose key climate change management practices to CDP.

With the goal of advancing its ability to track, measure and disclose key environmental performance data, **Broadcom responded to the following CDP surveys in 2015:**

- ➡ **Climate Change**
- ➡ **Water Disclosure**
- ➡ **Supply Chain**

Broadcom's 2015 CDP scores continue to show progress. In 2015, Broadcom earned:

- ✓ A Disclosure Score of 98 out of 100
- ✓ A Performance Score of A-

Broadcom's continuous annual CDP score increases are driven by a number of factors:

- ✓ Advanced transparency around the company's GHG management practices
- ✓ Demonstrated GHG emission reductions resulting from targeted efficiency measures
- ✓ Third party verification of emission data sources and calculation methodologies

One of the company's largest sources of greenhouse gas emissions results from operating corporate facilities. **Broadcom actively monitors utility consumption across its facilities to identify areas where fuel, electricity, water and other sources of GHG can be reduced.** In 2015, Broadcom's reported emission sources included natural gas, diesel fuel for backup generators, gasoline and diesel fuel used for corporate vehicles, fugitive emissions from HVAC refrigerants, purchased electricity, and corporate air travel.

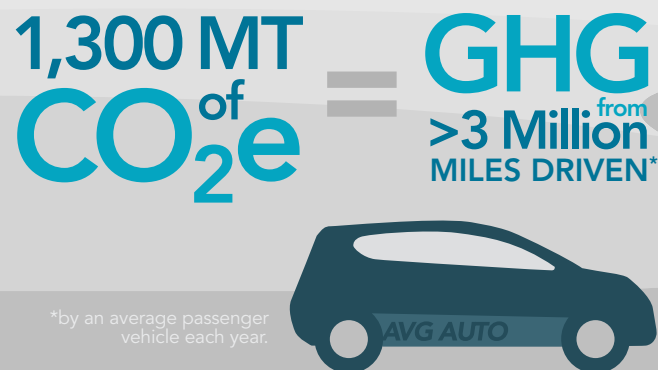
GHG EMISSION TRENDS

Recent Achievements

To limit its GHG emissions Broadcom has implemented a variety of energy efficiency projects, including:

- + Building retro-commissioning in San Jose, Calif.
- + LED lighting retrofit and HVAC optimization in Bangalore, India
- + Installation of a building automation system in Duluth, Ga.

The calculated energy savings from these projects is more than 2,300,000 kWh or 1,300 metric tons of CO₂e per year.



These and other energy conservation efforts have helped Broadcom surpass its emission intensity reduction target of 1 percent of total Scope 1 and 2 emissions per square foot per year.

In 2015, Broadcom expanded verification of Scope 1 and 2 emissions to include verification of Scope 3 emissions associated with employee business travel.

GHG Emission Intensities

Broadcom monitors GHG emission trends across three relevant metrics: CO₂e/SF, CO₂e/person and CO₂e per \$1 million revenue. From 2013 to 2014, Broadcom's Scope 1 and 2 greenhouse gas emission intensities changed by:

- 3.6 percent per square foot
- + 7.3 percent per person
- + 2.4 percent per \$1 million revenue

Absolute GHG Emissions

As the company evolves, energy efficiency initiatives become increasingly important to limit growth in absolute GHG emissions. Broadcom's absolute Scope 1 and 2 have increased due to an increase in the size of its overall building portfolio.

Broadcom's climate change strategy is driven by a Sustainability Steering Committee that is responsible for advancing the company's corporate citizenship initiatives.

This cross-functional group includes company leaders representing Engineering, Finance, Global Environmental Health and Safety, Global Real Estate, Human Resources, Information Technology, Legal, Quality Assurance, Regulatory, Sales, Treasury, Broadcom Foundation and Corporate Communications.
